The EOP:

- Sets roles and responsibilities for government agencies as well as private partners
- Activated when an emergency exceeds the capacity of a single agency or is beyond the scope of normal operations
- Plans for all-hazards, based on Emergency Support Functions (ESF)
- "building blocks" of disaster operations

Neighborhood Initiative – Kevin Cleary, MOEM

"Team Baltimore" has extensive experience with the Incident Community System -ICS - responding to incidents and managing large scale events under Mayor Rawlings-Blake

- ICS supports a single set of objectives under a commonly-accepted management structure
- ICS supports cooperation, coordination & communication The Mayor asked us to test:

Can the ICS be used effectively to support objectives and deliver resources to a specific community in a non-emergency environment...creating a "Community ICS" model? Following ICS guidelines two Public Safety Initiatives have been successfully conducted, in the Oliver Community and in the Western District. Objectives of the initiatives included support of BPD operations, engage community members, and connect residents with resources. Door knocking teams comprised of BPD, BCFD, PRA and community representatives were dispatched, Resource Fairs were conducted and community meetings were held during each of the initiatives.

Community ICS Conclusion:

- ICS is an effective management tool for mobilizing resources during non-emergency community interventions
- Agencies & stakeholders familiar with EOC activation comfortable with ICS model those not normally activated less so – broader training and exposure is encouraged

Health Department Report – Adam Conway

The Code Read Heat Advisory program is up and ready to provide the necessary resources during the notoriously hot weather period in Baltimore City particularly during the months of July and August. Weather monitoring is being conducted. Public messaging will be established on the BCHD website and at the 311 call center which will include information on cooling center locations where water will be provided.

Also being monitored are several disease outbreaks throughout the world which have not yet impacted the US. Such as:

- Bird Flu in China (so far only from actual contact with birds/poultry not human to human contact
- Middle Eastern Respiratory Syndrome in Saudi Arabia and Yemen. There was one case reported in Great Britain but that person had recently returned from a trip to the Middle East. So far there have been 77 confirmed cases which resulted in 40 deaths from this disease.
- Mortality rates from both diseases are expected to fall as more cases are identified.

Corrigan Sports has partnered with the City to host the Baltimore Running Festival for the past 13 years. The event which is held on either the first or second Saturday of October has raised more than \$8 million for charities since its inception. Also, an estimated \$38 million is pumped into the economy and \$750K is generated in local taxes each year. Emergency Preparedness, Medical Preparations, Security and Communications planning are well underway for this year's festival.

- Conducted public outreach meetings focused on floods
- Currently completing data analysis and writing the plan
